## Approved Minutes of the March 13, 2022 Board Meeting

The Board requested the treasurer to review the associations finances to determine what funds will be available to complete the repairs along with the last assessment funds.

A motion to adjourn at 3:00 PM was made by Wongstrom and seconded by Krueger, Motion passed with all members voting in favor.
